All critical components used for the detection and collection of DNA material have been quality controlled by testing a representative sample and analysed for the presence of DNA. This process is carried out by ISO 17025 accredited forensic laboratories.

#### **DNA Denatured:**

Components are treated with Ethylene Oxide (EtO) to denature any possible background DNA to a point where it cannot be amplified. Ethylene oxide is a gas that kills bacteria, mould and fungi.

#### ISO17025 Compliant:

Components are validated by an ISO17025 accredited analytical forensic service provider.

#### Meets FFLM guidelines:

Product follows the recommendations of the Forensic Science Committee of the Faculty of Forensic & Legal Medicine of the Royal College of Physicians. The FFLM is set up to develop and maintain the highest possible standards of competence and professional integrity in forensic and legal medicine.



# Evidence Recovery Systems: Trace DNA

DNA analysis is frequently used to acquire information from biological material to aid enquiries associated with criminal offences, disaster victim identification and missing person investigations.

With the recent introduction of DNA-17, analysis techniques for DNA profiling has advanced. By using DNA-17 technology there is greater increase in potential matches from trace evidence found at a scene or on a suspect person.

Due to increased sensitivity it is paramount that stringent anticontamination practices are followed at all times. SceneSafe follow current guidelines set in place through ISO/DIS 18385 to ensure that every step is taken to maintain evidential integrity.





# **Evidence Collection: Firearms**

## **Gunshot Residue (GSR)**

Primer residues can be retrieved by repeatedly sampling with adhesive tapes, or stubs, on to skin, clothing or other surfaces or by sampling suitable non-fabric surfaces with swabs. Propellant additives are recovered by either, vacuuming clothing and other surfaces, or by swabbing non-fabric surfaces. The resulting samples can also be analysed for primer.

#### Persistence of GSR

GSR is quickly lost from the hands but may persist for slightly longer on the face and hair. It can remain for up to a day on the other surfaces of clothing and indefinitely inside pockets depending upon the amount of disturbances.


